A MEETING OF MINDS: OUR ANNUAL FULL MANAGEMENT CONFERENCE MEETING

In mid-November we held our annual full management conference meeting. This was our first and only meeting of the year as we spent most of the year working on edits to the CCMP. We updated the conference on all we have been doing over the past year, provided updates on the CCMP edits, and laid out next steps on our road to certification. We also introduced our new team members to the conference, as well as solicited input from them on the monitoring plan. We wrapped up the meeting with some Q & A about items discussed and how the program will move forward with certification.





ANOTHER SUCCESSFUL ANNUAL COASTAL CLEANUP

We held our annual coastal cleanup on October 18th this year and it was another great success. 954 volunteers rallied to collect over 1700 lbs of trash from our 10 sites across the coast! Cigarette butts continue to be our highest picked up item, with volunteers removing over 9500 of them. Remember to properly dispose of trash when you visit our beaches and waterways and if you are interested in running your own clean up with friends, family, or work, we offer the request-a-bin program year-round! ASSOCIATION OF NATIONAL ESTUARY PROGRAM FALL TECH TRANSFER

During the first week of November, the MSEP team headed over to Mobile to attend the Association of National Estuary Programs' Fall Tech Transfer. This 3-day event was a wonderful opportunity to network with members of the 28 NEPs and to learn from their trials and successes. Mobile Bay NEP served as the conference host and had wonderful field trips showing the impact that they along with their community partners have made on their estuary and watershed.

MSEP PARTNERS WITH DMR ON MONOFILAMENT RECYCLING

Each month, our team partners with MDMR to empty every one of these stations and bring the collected material back to the Coastal Research and Extension Center. There, we sort and analyze the waste using the Escaped Trash Assessment Protocol (ETAP) to better understand what's really ending up in these bins – and let's just say, it's not only fishing line being tossed in! Properly recycling your used fishing line helps protect wildlife and keep our coastal waters clean. Next time you reel in, make sure your old line goes in a recycling tube near you, but please no trash!!

New Project: ART DOING ITS PART!

The Mississippi Sound Estuary Program (MSEP) alongside the Land Trust for the Mississippi Coastal Plain announces a statewide art and slogan competition: Art Doing Its Part. The competition seeks youth artwork depicting or inspired by reducing trash in freshwater and marine systems to raise awareness of the connection between local litter and the pollution of our waterways. The high school competition is aimed at personalizing the issue for communities by showcasing litter challenges specific to their regions, illustrating how local actions impact local and distant environments. By fostering a sense of shared responsibility, the contest encourages communities to take pride in their surroundings and actively participate in waste reduction, prevention, and cleanup efforts.

We are actively looking for organizations to serve as regional hub spots to organize and oversee the regional competitions. Each of the 7 selected agents will receive a \$10,000 reimbursable stipend to offset the cost of their individual regional competitions.

THERE IS STILL TIME TO LEND YOUR VOICE!



Recently the Enhancing Science, Treatment, and Upkeep of America's Resilient and Important Estuarine Systems (ESTUARIES) Act (House Bill (H.R.3962), Senate Bill (S.2063)) was brought before congress to reauthorize the National Estuary Program (NEP) that is administered through the Environmental Protection Agency (EPA). This bill would reauthorize the NEP through 2031, providing funding to the 28 nationally recognized estuary programs.

Mississippi is one of 3 states and the only Gulf state to not have a national estuary program. We hope that with this reauthorization, congress and the EPA will hear our call to certify the Mississippi Sound Estuary as an estuary of national significance and provide MSEP with the designation of being a national estuary program.

What you can do →

What would that mean?

The annual funding that the MSEP would receive from the NEP would fund our goals and actions as outlined in our CCMP. This means annual funds for conservation, restoration, and stewardship of the Mississippi Sound Estuary and its watershed.

Where we stand.

MSEP has been amended to H.R. 3962 which passed committee and awaits a final House vote. The Senate bill (S.2063) still needs to match the amended House version and be voted on as well.

HERE'S A SAMPLE SCRIPT TO SEND TO YOUR CONGRESS MEMBERS:

"[TITLE OF YOUR CONGRESS REP], I'm writing to ask that you support the Enhancing Science, Treatment, and Upkeep of America's Resilient and Important Estuarine Systems (ESTUARIES) Act (House Bill (H.R.3962), Senate Bill (S.2063)) that was introduced on the House and Senate Floors on June 12th. This bill would reauthorize the EPA's National Estuary Program through 2031, ensuring that estuaries of national significance continue to receive federal support. The federal funding NEPs receive enables crucial work to be carried out that is critical to conserve and restore the ecosystem, culture, and community of the estuary.

The Mississippi Sound Estuary Program (MSEP) is seeking to become the state's National Estuary Program. Encompassing approximately 21,000 square miles between the Pearl and Pascagoula Rivers, the Mississippi Sound Watershed covers roughly a third of the state and houses just over half of the state's total population.
